



NOTES FOR CORPORATE MEMBERSHIP APPLICANTS

1 APPLICATION FORM

- 1.1 The application form is to be submitted by the company.
- 1.2 The application form is to be accompanied with a cheque for either \$7725.40 for a single nominee or \$8495.80 for two (2) nominees; inclusive of GST to 'SIA Group Sports Club'.
- 1.3 In the event that the company withdraws its application after it has been approved by the SIA Group Sports Club the deposit for the corporate membership fee of \$6,000 will not be refunded and will be forfeited.
- 1.4 In the event that the application is not approved by SIA Group Sports Club then the deposit will be refunded.

2 CHILDREN AS FAMILY MEMBERS

- 2.1 Children below 18 years of age of the nominee are considered family members and will be allowed the use of the Club facilities, if accompanied by parents.
- 2.2 Children above 18 years of age are not considered as family members and will not be eligible for inclusion as family members.
